Homework

Homework will be graded based on <u>completion - not accuracy</u>.

Completion means serious effort. I want you to attempt every problem, and if you don't finish a problem, give an explanation for why (What concept are you struggling with? Could you solve a similar problem if a small part of it was changed? Etc?) You are encouraged to work in groups of any size, but at most five names can be submitted per copy of homework.

I will post the answer key for the homework end of business day Monday. I will drop two homework assignments.

Exams

Quizzes: We will have 5 quizzes. The calendar for quizzes is online. Quizzes are held on **Wednesday**. No makeups or separate time quizzes will be given unless you have documented accommodation. You must notify me with documentation of your accommodation before the first quiz by 1/20/20. All quizzes will be held in the normal classroom during the normal time. **I will drop your lowest quiz score at the end of the course**.

If you will travel during the semester for **university sponsored content**, you **must** meet with me at the **start of the semester** so we can map out which quizzes you will miss and develop a fair plan for evaluation.
